Section 1: Purpose

This Letter of Agreement (LOA) defines the ownership hierarchy for providing ATC services to the Thompson, Hudson, and Severn high-level sectors (FL290 and above).

This change reflects the real-world ownership of this airspace.

Section 2: Description of the Airspace

The airspace described below delegated to the Edmonton FIR by the Winnipeg FIR is also illustrated in Appendix B.

Section 3: Ownership Hierarchy

Edmonton (CZEG) and Winnipeg (CZWG) are responsible for providing air traffic control services (ATC) within their respective FIRs in accordance with Nav Canada boundaries and VATSIM COC/COR and VATCAN policies, and local SOPs. The ownership of the sectors pertaining to this LOA is detailed in the table below.

Sector	Owner
Thompson (FL290 and above)	CZEG
Hudson (FL290 and above)	CZEG
Severn (FL290 and above)	CZEG

CZEG will assume responsibility for providing air traffic services for high-level sectors (FL290 and above) Thomson, Hudson and Severn.

Section 4: Inter-FIR Operational Procedures When Both FIRs are Operating

Unless otherwise coordinated, Edmonton and Winnipeg ACCs are responsible for the relay of IFR and CVFR flight plan data between adjacent ACCs for all flights crossing the common control boundary.

As defined by Euroscope and normal practice within VATCAN, established procedures will be followed by the respective ACCs for transfer of control (TOC) defined as handoffs, transfers or releases.

Section 4.1: Edmonton Controller Frequencies

Winnipeg controllers should refer to the following table when initiating a TOC of an aircraft inbound to, or entering, the Edmonton FIR when an CZEG_FSS or CZEG_CTR is online.

Section 4.2: Winnipeg Controller Frequencies

Edmonton controllers should refer to the following table when initiating a TOC of an aircraft inbound to Calgary when an Edmonton Controller is online.

Within the CZEG sector files, Winnipeg Centre is defined as WPC operating on a frequency of 124.00. Winnipeg FIR will advise the Edmonton FIR if additional Ownership Hierarchy and Controller Positions are to be added.

No further sector files changes are required prior to the signing of this agreement. However, both FIR Chiefs will ask their respective Facility Engineers to discuss any inter-FIR changes and additions which could improve the workflow for this LOA.

Section 6: Delegation of Signing Authority

The signing authority to amend any portion of this LOA, including attachments, is delegated to the CZWG and CZEG FIR Chiefs or their designated representatives. All amendments must follow the proper review and validation process and must have received approval from both FIRs.

Section 7: Annual Reviews and Initial Six-month Evaluation

It is agreed that at six months from the initial effective date and on an annual basis from the effective date of November 2, 2022, an evaluation will be conducted for the purposes of assessing the outcome on the implementation of this LOA.

CZEG and CZWG FIR Chiefs or delegates will communicate with all parties, including but not limited to CZUL, CZYZ, VOLANTA, VATSPY and SIMAWARE about these changes to ensure proper coordination and TOC between FIRs and to minimize pilot confusion when transiting this airspace.

Section 8: Communication

Communication of the implementation of this Letter of Agreement, or termination thereof, must be sent by both FIR Chiefs, or their assigned delegates, to the respective certified controllers and posted on the respective FIR websites and VATCAN forums.

Appendices from the original LOA between CZEG and CZWG from 26 May 2016 are relevant for the purposes of this Letter of Agreement and are included as part of the LOA.




Appendix B: Edmonton Airspace with High and Low Sectors and Surrounding FIRs and ARTCCs








Appendix B: Edmonton Airspace with High and Low Sectors and Surrounding FIRs and ARTCCs
